COMMENTS:

Request to combust is being made as a result of Anadarko/Western Midstream shutting down their Third Creek Gathering System in May of 2018 which was the gas sales outlet for the Champlin 126 Amoco B#6. Attempts to acquire strategic portions of the Third Creek System have been stymied by Anadarko and their complete unwillingness to consider any transfer of ownership. Anadarko/Western Midstream also operates the only other active gas infrastructure within 10 miles of the lease. Anadarko/Western's Wattenberg Gas Gathering System is approximately 8 miles away and could be hooked up utilizing a good now abandon high pressure piping segment of the Third Creek System located only 1/8 mile from the CPC 126 Amoco B tank battery. Anadarko/Western has been completely unresponsive to these proposals and ideas.

Alternative creative natural gas uses are being explored as a possible solution to the gas deosition dilemma. It is estimated that approximately 1 1/3 MCFD from the well will be flared using a central tank battery 98%+ combustor. A gas sample collected 8/10/2020 showed H2S concentrations below detectable limits and is attached.

This flaring request is being made necessary by the completely unprecedented shutting down in May of 2018 of the Anadarko/Western Third Creek Gathering System. The Champlin 126 Amoco B#6 is making approximately 2/3 BOPD and 1 1/3 MCFD. Oil revenue dominates the economics of this well.
Given Anadarko/Western Midstream Partners defiant attitude in utilizing their legacy assets in the area to reconnect wells it is not known when a gas deposition solution will be found for this leases gas combustion. It is hoped that the COGCC could possibly broker a resolution to this impasse.
