Comment: The location has no vegetation growth on approximately 100'x150' area. The surrounding field has a uniform vegetation cover but was not planted into cropland this season. There are likely soil issues that is impacting growth of vegetation. A soil analysis should be performed to evaluate soil conditions to ensure crop establishment. The location will need to be reclaimed to reestablish a uniform crop cover. Previous corrective action was not completed.
