This form is being submitted to comply with COGCC Rule 911.a.(4). The form serves as the initial notification to abandon the ROLES #13-10 (J13W) (API# 05-045-06953) well and associated infrastructure. Equipment to be removed includes a wellhead and associated on-site flowline which will be abandoned in place.

As part of the "cut and cap operations" Caerus will excavate the ROLES #13-10 (J13W) wellhead. Caerus will visually inspect and field screen the base and sidewalls within the wellhead abandonment excavation. Additionally, Caerus will field screen the approximate connection points of the flowline to surface equipment. If field screening indicates impacts to soil in any of these locations, the sample exhibiting the highest degree of impacts based on field screening will be collected from the associated area and submitted for laboratory analysis of the full list of constituents in COGCC Table 915-1. Any impacted soil will be segregated, stockpiled on site, and the extent of impacts will be investigated through additional excavation and confirmation soil sampling.
