Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed well is shut in. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife black bear Management and Density habitat.

Previous inspection documents #702800198 and # 702800491 have multiple C/A's that have not been completed. Therefore all C/A dates remain the same.

During this inspection the following compliance issues were observed:

1. Safety labeling is missing (6/12/2022)
2. Random debris (5/19/2022)
3. Stored supply (8/12/2022)
4. Random staining (6/12/2022)
5. Wildlife protection BMP's absent (5/16/2022)
6. Dead men lacking markers or not properly marked (5/26/2022)
