Comment:	<p>Russian knapweed (List B Noxious) was observed at the northwest of the Location. Cheatgrass is widespread and halogeton is occasional (List C Noxious). Annual wheatgrass (undesirable plant species/weed) dominates portions of the Location at the northwest and southwest within the tank battery fence.</p> <p>A fall corrective action date is given due to the presence of Russian knapweed. Operator is encouraged to determine the best method and timing for treatment of each particular species. Ongoing management is required.</p>

Gravel and compacted soils are evident below a layer of soil spread over portions of the location and access road. Portions of the location vary in levels of reclamation and revegetation. Operator must determine areas requiring additional reclamation/seeding to achieve 1004 standards.</p> <p style="color: red;">Conduct additional reclamation in accordance with COGCC 1000 series rules. Remove fencing. Reclaim access road. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels on the Location and access road.
