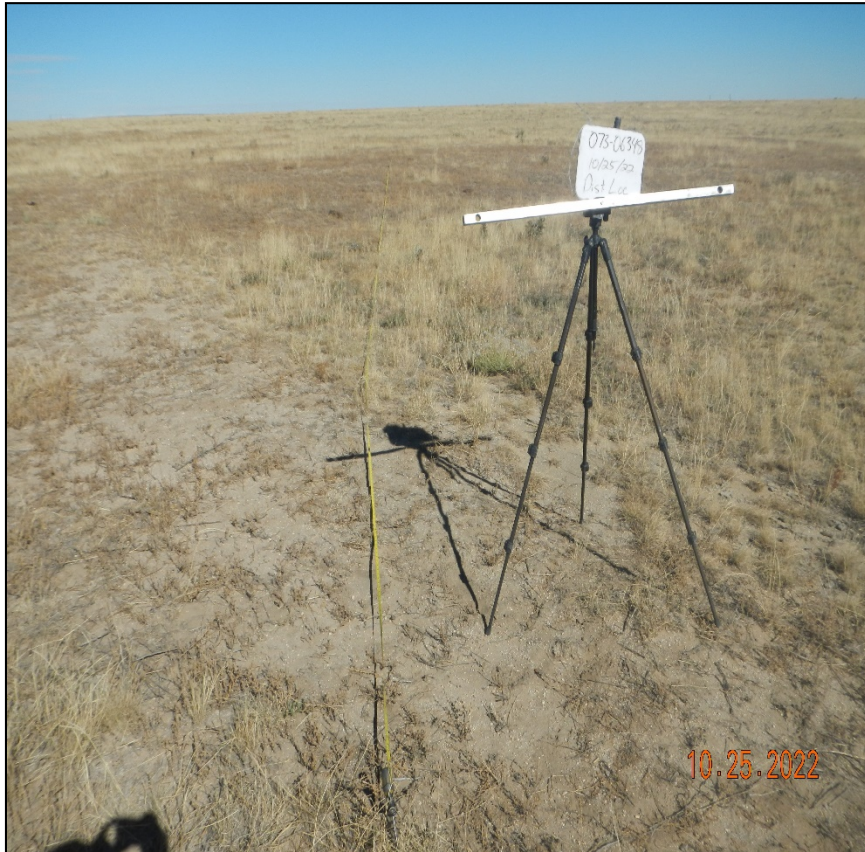


Photo 7. Facing northeast at the beginning of the transect at the location.

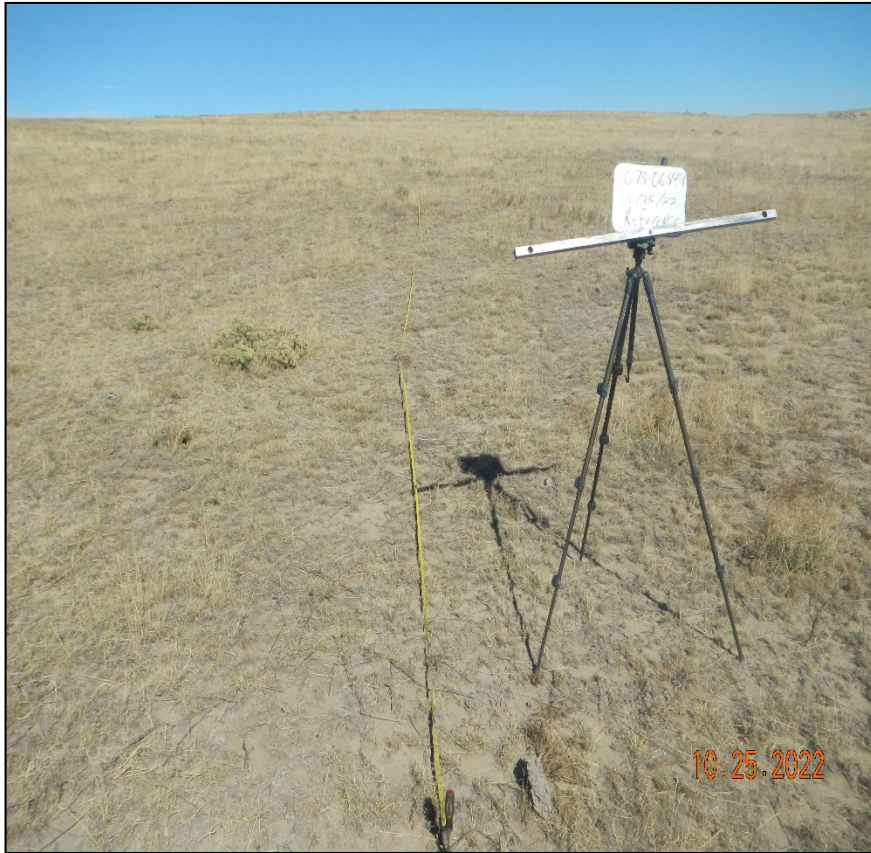


Photo 9. Facing northeast at the beginning of the transect at the undisturbed reference area.

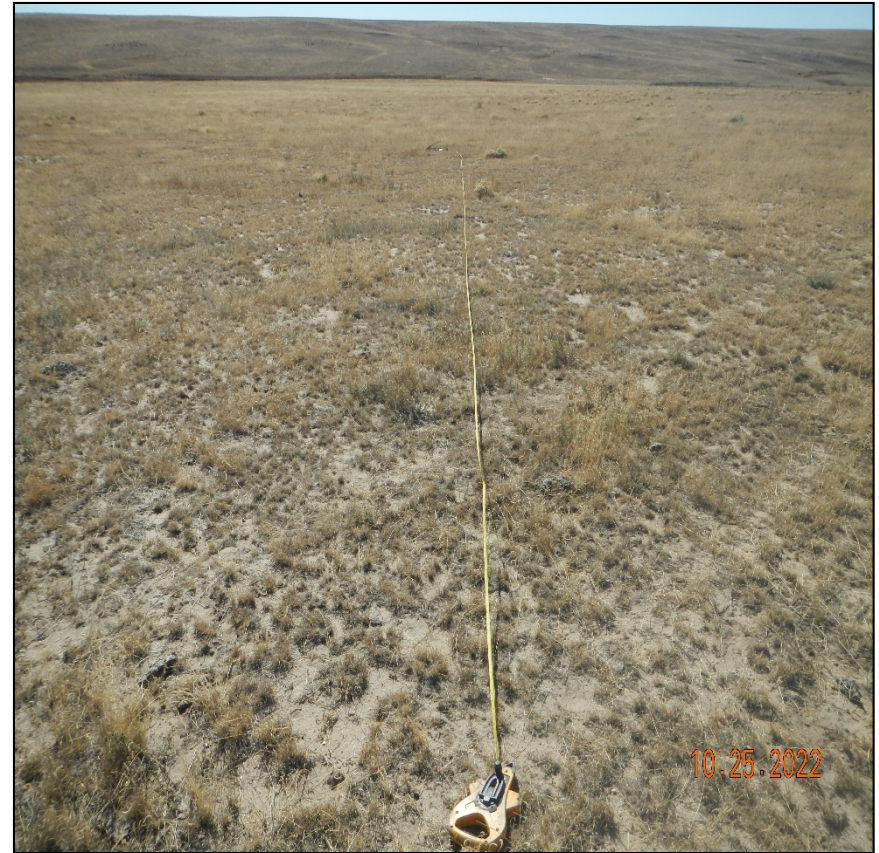


Photo 10. Facing southwest at the end of the transect at the undisturbed reference area.
