This is a follow up inspection to COGCC Inspection 707900076.

Unauthorized venting of gas observed during inspection 707900076 has ceased. Venting: Rule 903 d (2) Corrective action date of 10-20-22 has been completed as of this inspection. Operator may wish to submit FIRR form to document date venting ceased to decrease financial penalty to be assessed during Enforcement action.

Unused equipment (2" steel pipe and 1" poly) and stained soil observed during inspection 707900076 has been removed as of this inspection.

Stained soil in containment observed during inspection 707900076 appears to be removed. Per Rule 912.a.(5) operator shall submit documentation of cleanup of stained soil via FIRR. Operator shall demonstrate that soil inside containment is compliant with COGCC Table 915-1. If exceedances of 915-1 are observed operator shall submit Form 27 Remediation Plan to address impacts to soil.
