It was observed in this inspection that two (2) risers are present at the intersection of the Location access road and County Road 89.

Per Rule 1004.a all debris, abandoned gathering line risers and flowline risers, and surface equipment shall be removed within three (3) months of plugging a well. Corrective action date is set at 2/3/2018, three months from plugging.

At the time of this inspection the Location and access road are well vegetated with desirable perennial grasses, forbs and shrubs. No noxious weeds were observed. Location is progressing towards 1004 vegetation standards.
