Comment: The desirable vegetation has not reestablished to at least 80% of reference area levels. There are areas of the location that have minimal vegetation and/or undesirable weeds. The location needs to be reseeded by the upcoming spring growing season. Additional growing seasons may be needed along with continued monitoring and management practices to ensure vegetation establishment meets the final reclamation requirements.
