Propose to plug and abandon well in the following manner:

1. Will place 10 sax plug with dump bailer from 6175' to 6125'.
2. Determine free point of 7" casing, shoot off and recover casing.
3. Place 50 sax plug at base of surface pipe at 240'.
4. Cut off casing 4' below ground level, place 10 sax plug in top of casing and weld steel plate on top of casing stub.
