This Supplemental Form 27 is being submitted to provide facility closure documentation for the Vision Energy Ruby Lee 2-32-8-101 site (previously operated under Maralex Resources)

As outlined within the Initial Form 27, samples were collected from the wellhead. This well was not tied into a pipeline and not produced. Results indicated a negative hydrocarbon concentration in all areas sample. Confirmation samples were collected from the surface (0-6") and submitted to the lab for COGCC Table 915-1.

Sample results indicate soils satisfy COGCC Table 915-1 with the exception to Arsenic which also exceeds in the background samples.

Vision Energy is requesting closure of the facility ID's & API noted within the Form 27 and permission to proceed with final reclamation of the site.
