	<p>This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 09/12/1968. During this inspection, COGCC Staff observed that the location had not been recontoured to reflect adjacent reference areas and a pile of road base/gravel (approx 20' x 20' in size) remain on location. Undesirable vegetation (e.g. russian thistle and kochia) and areas of bare soil were also observed throughout the location. Refer to attached inspection photos.</p>	
Corrective Action:	<p>Comply with Rule 1004. Operator shall remove road base/gravel and contour/grade the location; perform de-compaction by cross-ripping to a depth of 18"; and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p>The corrective action date is the date the location was observed out of compliance.</p>	Date <b>11/14/2022</b>
