Schneider Energy Services, Inc. (Schneider) is an operator in good standing, who is fully bonded under the current rules, and has no outstanding, delinquent, or overdue financial obligations relating to the Commission, or its vendors, contractors, royalty owners, or other parties. Schneider has complied with the insurance requirements as provided for under COGCC Rule 705. Schneider is a privately held, solvent company whose operations meet the standards set forth in COGCC rules. Schneider has regularly conducted remediation/reclamation operations and is the owner and operator of certain equipment that it uses to plug and abandon wells. Finally, as COGCC records would show, Schneider has averaged plugging over 3 wells per year over the previous three calendar years. In 2022, Schneider has P&A'd 2 wells thus far. Schneider believes this publicly available evidence satisfies the requirements put forth by Rule 434.d.(4). Based on the timeline put forth under the rules, and the number of wells Schneider has placed on the Out of Service (OOS) list, the evidence clearly illustrates Schneider's current and historic ability to comply with its obligations.
