Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Operator shall contact COGCC Environmental Staff Chris Canfield to determine status of monitoring wells.

Final reclamation activities shall be complete no later than 11/17/2022 or as soon as environmental conditions will permit.
