Per 600 series rules active oil and gas locations can not be used by public. Multiple vehicles, tents, generators, fuel observed on pad.

In addition to having camp removed, operator should employ measures to preven tsuch use of this and similar locations in the future such as controlling access, self inspecting, using signs to deter inappropriate use such as "no unauthorized personnel", "no camping", etc.

Operator should also work with CPW and FS staff on issue.
