In response to NOAV doc. #403003375, this Supplemental Form 27 is being submitted to provide documentation regarding the AP 41-14-695 pit closure (Facility ID #279358) that occurred in 2015.

Closure actions were conducted on July 8, 2015 and concluded on July 27, 2015. Ongoing sampling was conducted with the final landfarm sampling being completed on 9/1/2015. A Notice of Completion (NOC) report was drafted on 9/8/2015 requesting closure of the pit.

See attached NOC report for a summary of the closure actions and documentation.

Please note that the NOC report was drafted in 2015 which was under the former owner (WPX Energy) and is referenced as the operator within the report. Terra Energy has since resumed ownership of the WPX assets.
