Comment:

	<p>This location does not comply with Rule 1004. It appears the location was built but no wells were ever drilled. The location was subsequently reclaimed as topsoil appears to have been placed back to its relative positions and the entire location contoured and graded. However, there is a perimeter fence installed around the location and the location is predominantly undesirable vegetation (e.g. russian thistle and kochia). The entire location will need to be managed for undesirable vegetation and reseeded to comply with 1004 Rules. Refer to attached inspection photos.</p>	
Corrective Action:	<p>Comply with Rule 1004. Remove fencing, manage undesirable vegetation and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p>Corrective action date is the date the location was observed out of compliance.</p>	Date 12/01/2022
