While there, I observed that the crude oil tank required a new NFPA placard and the produced water tank lacked all required placards. During this inspection the following possible compliance issues were observed: Rule 605.h. with a corrective action date of 2/10/2023. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
