Inspection required Operator to comply with 1002.f.</p> <p>It was observed in this inspection that stormwater and erosion control BMPs along the access road remain missing or insufficient; erosion/degradation remains apparent along access roads. Though waterbars were observed, properly engineered outlets were not observed. Original CA/Date remains applicable.</p>		
Corrective Action:	Comply with 1002.f.; Implement and maintain BMPs to control stormwater runoff in a manner that minimizes erosion, transport of sediment offsite, and site degradation on access road. Ensure controls are implemented in accordance with good engineering practices and maintained in proper functioning condition; regrading alone will not be sufficient to stabilize road and manage runoff.
