While there, I observed well normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

Previous inspection document # 700704366 listed potential compliance issues without C/A dates all of the issues are still in place. Therefore C/A's will have dates.

During this inspection the following compliance issues were observed:
