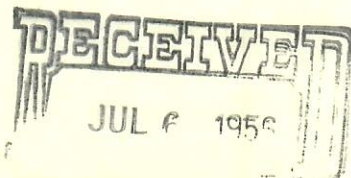

- 2' Sand & sh, rewrkd, mg, fr por. & perm, NS.
- 4½' Sand & sh rewrkd, fg, ashy, NS.

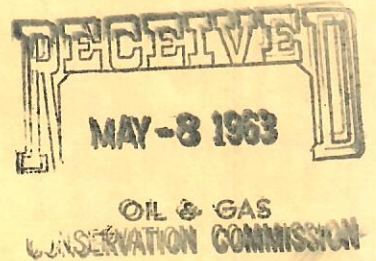
DST #1, 6030-45. Tool open 1 hr, slight blow at start of test to good blow at end of test, shut-in 20min, recovered 299' muddy water, IBHFP 350, FBHFP 300, BHSIP 1290, HP 3250. Tool was partially plugged at beginning of test.

DST #2, 6091½-99½. Tool open 2 hr, good blow, gas to surface in 45 min, recovered 190' heavy oil & gas cut mud & 60' slightly oil cut water, estimated 65 MCFGPD in 1½ hr through a 3/8" orifice, estimated 180 MCFGPD in 2 hr (stabilized) through a 1/2" orifice, IBHFP 0, FBHFP 50, BHSIP 1550, HP 3350.

DST #3, 6135-51. Tool open 1 hr, 50 min, good blow at start, decreased to fair at end of test, shut-in 30 min, recovered 1000' gas in drill pipe and 540' slightly oil & gas cut muddy water, IBHFP 0, FBHFP 175, BHSIP 1550, IHP 3500, FHP 3350.

SUNDRY NOTICES AND REPORTS ON WELLS

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplete or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, report is necessary.
