9-8-80	0 hours	Moved rig. Raised mast. Hooked up lines. Worked rods loose. Started pulling.
9-9-80	0 hours	Finished pulling rod. Started pulling tubing.
9-10-80	0 hours	Finished pulling tubing.
9-11-80	12 hours	Ran sand to 6200'. Dug cellar. Set in jacks. Worked pipe to 48". Loaded hole. Dumped 5 sacks cement on sand at 6200'. Shot at 5200'. Water truck, 6 hours.
9-12-80	9 hours	Worked pipe to 52". Shot at 5100'. Worked pipe to 54".
9-15-80	5 hours	Worked pipe at 54". Loaded junk rack. Lowered poles. Moved off.
9-17-80	0 hours	Pumped 50 bbl oil down casing, at 2500#. Followed with 130 bbl water. Last 30 bbl water pumped at 1500#. Pump Job.
10-24-80	0 hours	Moved rig back on well.
10-27-80	9 hours	Raised mast. Set in jacks. Worked pipe to 50".
10-28-80	10 hours	Worked pipe to 56". Shot at 5000', 4700' and 4500'. Worked pipe at 56".
10-29-80	9 hours	Worked pipe at 57". Shot at 4300' and 4000'. Worked loose. Pulled 10 joints.
10-20-80	0 hours	Pulled 50 joints.
✓ 10-31-80	4 hours	Finished pulling casing, 136 total. Set 15 sacks cement in and out bottom of 8 5/8" at 267'. Mud-ded to 35". Set 10 sacks cement to 3' below ground level. Cut off surface. Welded on plate.
