Comment: There are two culverts installed at the stream crossing which is not sufficient as the prior crossing had 3 large culverts. Additionally it was observed that the crossing further upstream has 5 various size culverts. The stream crossing needs to be installed per good engineer practice. Previous corrective action was not completed. It appears a recent storm event has caused stormwater to flow over the stream crossing. Recent dozer work has been performed but no additional culverts were installed. BMP's must be implemented in accordance with good engineering practice and must be maintained.
