General Comment:**COGCC Inspection Report Summary**

On Monday 12/6/2022 at approximately 1100, I, Inspector Scott Ramsey, conducted a routine inspection at TEP Mead 30-12, at Location # 335121 in Garfield county Colorado.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad, there is approximately 40 feet of gravel at both entrances of location at time of inspection.

During this inspection the following compliance issues were observed:

1. Random debris at well head
