General Comment:**COGCC Inspection Report Summary**

On Tuesday 12/6/2022 at approximately 1200, I, Inspector Scott Ramsey, conducted a follow up inspection at Caerus R11, at Location # 334572 in Garfield county Colorado.

While there, I observed well normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

Previous inspection document # 700704367 listed potential compliance issues without C/A dates all of the issues are still in place. Therefore C/A's will have dates.

During this inspection the following compliance issues were observed:

1. Lack of battery signage
2. Open ended piping for thawing out dump lines on tanks and separators with exhaust from trucks.
3. Valve on tank missing cap/plug
4. Random debris/stored equipment

Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
