INITIAL ACTION SUMMARY

The RMPCO-UPRR-RHINE #1 well is in the orphaned well program (OWP) to be plugged and abandoned (PA) under a separate initial Form 27. This initial Form 27 is submitted for closing the UPRR Rhine #1 produced water pit and the associated remote Tank Battery production equipment. If impacted soils are encountered, the impacted soil will be excavated and temporarily stockpiled on location. Structural control measures and BMPs will be implemented to prevent surface water and groundwater impacts.
