INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize assessment activities conducted during the closure of seven aboveground storage tanks (ASTs) one produced water vessel (PWV), three emissions control devices (ECDs), three separators, and one 2-phase separator at the USA Fed Tank Battery 36C-36HZ Facility. The ASTs, PWV, ECDs, and separators were permanently removed. Assessment activities began on August 11, 2022. Soil assessment activities were conducted in accordance with COGCC Rule 911.a. A photo log is included as an attachment.

Between August 11 and August 18, 2022, soil samples were collected from the ASTs, PWV, ECDs, separators and ancillary piping (see Figure 1). The soil samples were field screened for total volatile organic compounds using a photoionization detector (PID). Based on PID readings, select soil samples were submitted for laboratory analysis. Analytical results indicated soil was in full compliance with Table 915-1 standards or the analytical variability of background at the extents of the excavations except for pH at a level of 5.43. However, there are no indications of either historical or active releases at this location and the singular elevated pH result is not an indication of a release of hydrocarbons. The PID readings and soil sample results are summarized in Tables 1 and 2, respectively, and the laboratory reports are attached.

	The surface area disturbed by the remediation activity shall be reclaimed in accordance with the 1000 Series Reclamation Rules. For locations with active ongoing oil and gas operations, comply with Rule 1003 interim reclamation requirements and for locations that will no longer have active oil and gas operations, comply with Rule 1004 Final Reclamation requirements.
	Based on the information presented, the elevated pH sample from the spill area appears to be similar to background pH; therefore, elevated pH may not be associated with E&P activities. It appears that no further remedial action is necessary at this time and the COGCC approves the closure request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or background levels or if groundwater is found to be impacted, then further investigation and/or remediation activities may be required.
