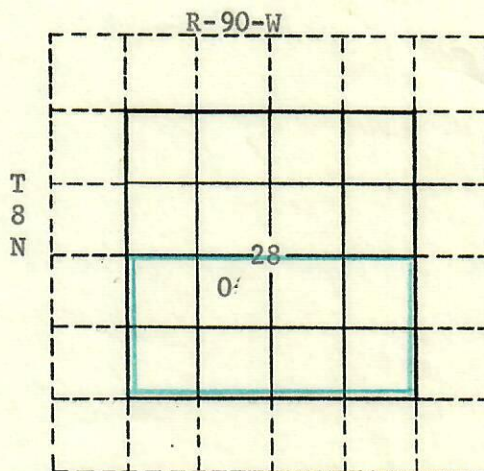
INSTRUCTIONS:

A notice of intention to drill a well shall be filed in duplicate on all Federal and Patented lands, and in triplicate on all State lands. Do not begin operations until approved copy has been received. It is mandatory that the proposed location comply with all rules and regulations of the Commission. Locate well on section grid in proper location, and indicate extent of lease. Unless operations are commenced within 180 days after the date of approval hereof, this approval to drill will become null and void.

REMARKS:

Operator proposes to drill to approx. 3500' to continue development of Basal Lance Gas reserves in the North Craig field. We propose to set 300' of 8 5/8" surface casing with sufficient cement to circulate. Cores and tests will be taken if warranted. In the event of production we will set 5 1/2" production casing 100' below the lowest oil or gas zone with sufficient cement to fill the annulus 300' above uppermost oil and gas zone. Electric log will be run from base of surface casing to total depth.
