Comments:

The associated centralized battery is permitted separately (317543). All surface disturbance associated with the GRENEMEYER 24-26, 4-6-26 Well Pad and Location ID 335620 was reclaimed in fall of 2019 and has been successfully revegetated when compared to the surrounding reference based on the results of a vegetation survey completed in summer of 2021. The well site is located within agricultural land that has not been cultivated with crops in 10 years. Because of this the land use is considered non-crop, as identified in a 2015 COGCC inspection (Doc # 673802483), and the reclaimed surface was seeded with perennial grasses. Please see the attached report for additional site information, details on the completed vegetation survey, and photo documentation.
