Attention Chris Binschus:  
A Form 10 Change of Operator was submitted through the API for the SCHAFFER K 15-33 Well. The associated facility is located at 40.311320,-104.773700 as noted in the 04/04/2014 COGCC inspection (Doc # 674100556). The facility is permitted separately alongside the producing Schafer # K16-64-1HN Well (Loc ID 433828, API: 05-123-37807). No permanently stabilized access road was constructed for the site; the location was accessed via an agricultural service road parallel to CR31 then west to the well. All portions of the disturbance associated with the SCHAFFER K 15-33 Well have been fully reclaimed and returned to cropland. Please see the attached report for additional reclamation activities, details on the completed reclamation assessment, and photo documentation.
