Comment:	Scotch thistle, a CO List B Noxious Weed was observed occasionally throughout the location. Scotch thistle was observed to be widespread, although sparse throughout the general area (Clough wells south of highway 6). Due to the number of plants observed which have gone to seed, it appears management will be necessary in subsequent growing seasons.

Areas of the location not needed for production, or no longer in use have been reduced and reclaimed. Portions of the interim areas appear vegetated with introduced perennial grasses and native shrubs. However, annual undesirable plant species appear to have colonized portions of the location where seeded species are absent. Snow cover and dormant season prevented full vegetation assessment. A follow up inspection will be performed in a subsequent growing season to assess interim area revegetation.
