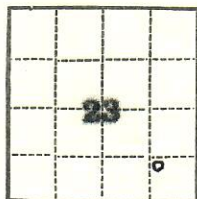
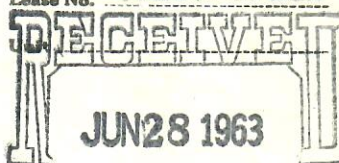

Hondo Oil & Gas Company deepened the No. 1 Federal 825 feet with air from 6675-7500. A 4-3/4" hole was drilled from old total depth of 6675 to present total depth of 7500 feet. Top of Carlile Shale 7460. No logs or additional casing were run in this well. After reaching total depth well was placed back on production and completed natural. A small increase in daily production of 3 to 4 barrels of oil has been noticed to date.
