Pursuant to COGCC Rule 911 a site investigation was conducted at the WEBSTER 15-28 wellhead cut and cap and flowline removal. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead was cut and capped per COGCC rules. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

Twelve soil samples were collected during the site investigation. Soil samples were analyzed by a certified laboratory for GBTEXN, TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron.

Impacted soil will be excavated. If monitoring wells are destroyed during excavation activities, they will be re-installed to continue quarterly groundwater sampling. Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site. If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to COGCC in a supplemental Form 27.

Groundwater will be sampled on a quarterly basis until analytical results are reported with concentrations Table 915-1 analytes below regulatory limits for four consecutive quarters. Five monitoring wells (MW-1 through MW-5) are sampled on a quarterly basis to monitor groundwater quality. Groundwater monitoring wells were sampled and submitted to a laboratory for analysis of Table 915-1 groundwater constituents: Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS). Please note that the large majority of exceedances reported in the site investigation report section (14/15 samples) were inorganic exceedances since there is not an established background monitoring well at this location.
