Inspector acknowledges that musk thistle was treated in June of 2022. However, it appears additional weed management is necessary in 2023, per FIR #702800901. Inspector also acknowledges that TEP will continue to inspect, monitor and treat weeds. However, the "date of completion" of 1/12/2023 appears to be the date the form was submitted. Based on Operator comments, it does not appear that weed management was performed after the 11/7/2022 inspection date.
