- 1 Pulled 2-3/8" tubing and retrievable packer.  
Dump bailed 6 sx. of cement on bottom. Checked top of cement plug after set at 2042' depth with measuring line.  
Cut and pulled 5-1/2" casing at 1069' depth.  
Set 20 sx. cement plug thru tubing from 1110' to 1010' depth.  
Set 30 sx. cement plug thru tubing from 360' to 260' depth.  
Cemented in marker in top of 8-5/8" surface casing with 10 sx.  
Interval between plugs heavy mud.
