Proposal Notify Oil & Gas Conservation Commission minimum of 48 hours prior to work.
Existing perfs at 2038-68' now below BP @ 2030' w/ 1 sxs cement.
PROPOSED NEW WORK TO ABANDON WELL
Set bridge plug at approximately 1,919'. (50' above top perforation. Open perfs 1969-79' & 1994-2004'). Dump ^{2 sxs} sxs cement on plug.
Perf squeeze holes at 360'. (50' below surface casing shoe)
Break circulation up 5-1/2" - 8-5/8" annulus and pump/squeeze balanced plug of 50 sxs Class "G" cement into perfs at 360'.
Pump 50' (6 sxs) Class "G" cement plug from 50' to surface.
Run 1" tubing down 5-1/2" - 8-5/8" annulus and pump 50' (8 sxs) Class "G" cement plug from 50' to surface.
Cut off wellhead and casing 30" below ground level and weld steel cap on 5-1/2" casing. Reclaim location.
Request approval to commence work in early August after hay has been harvested from fields. Surface owner has also requested this commencement date.
