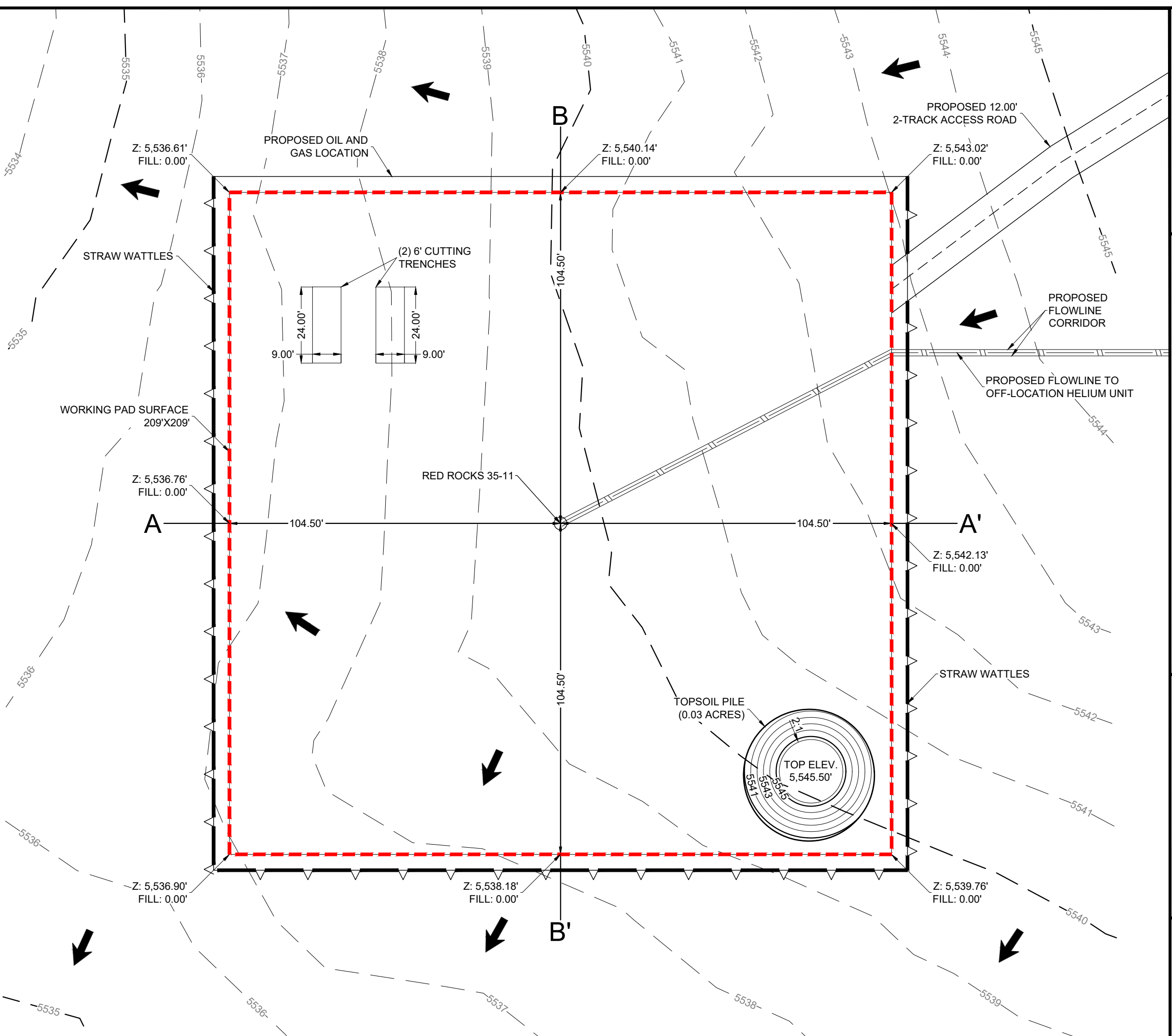

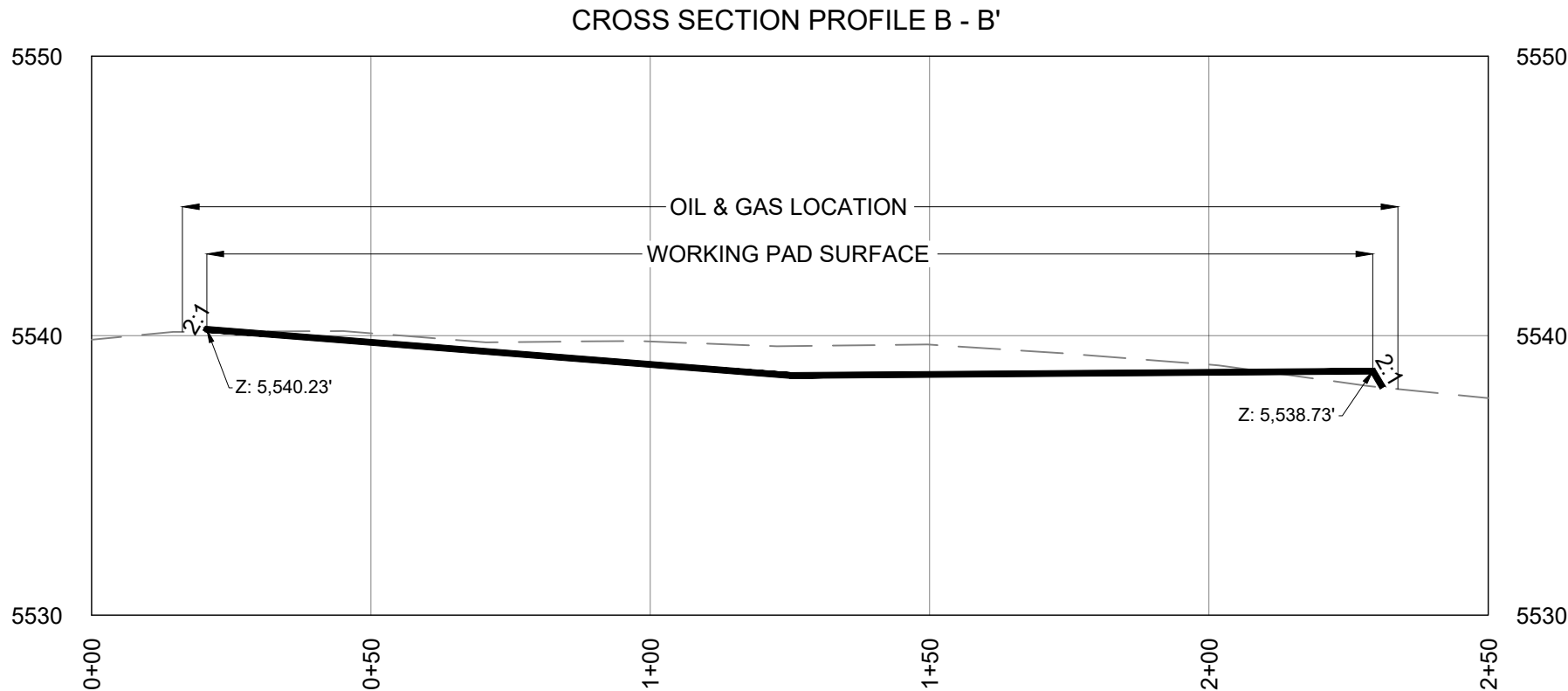
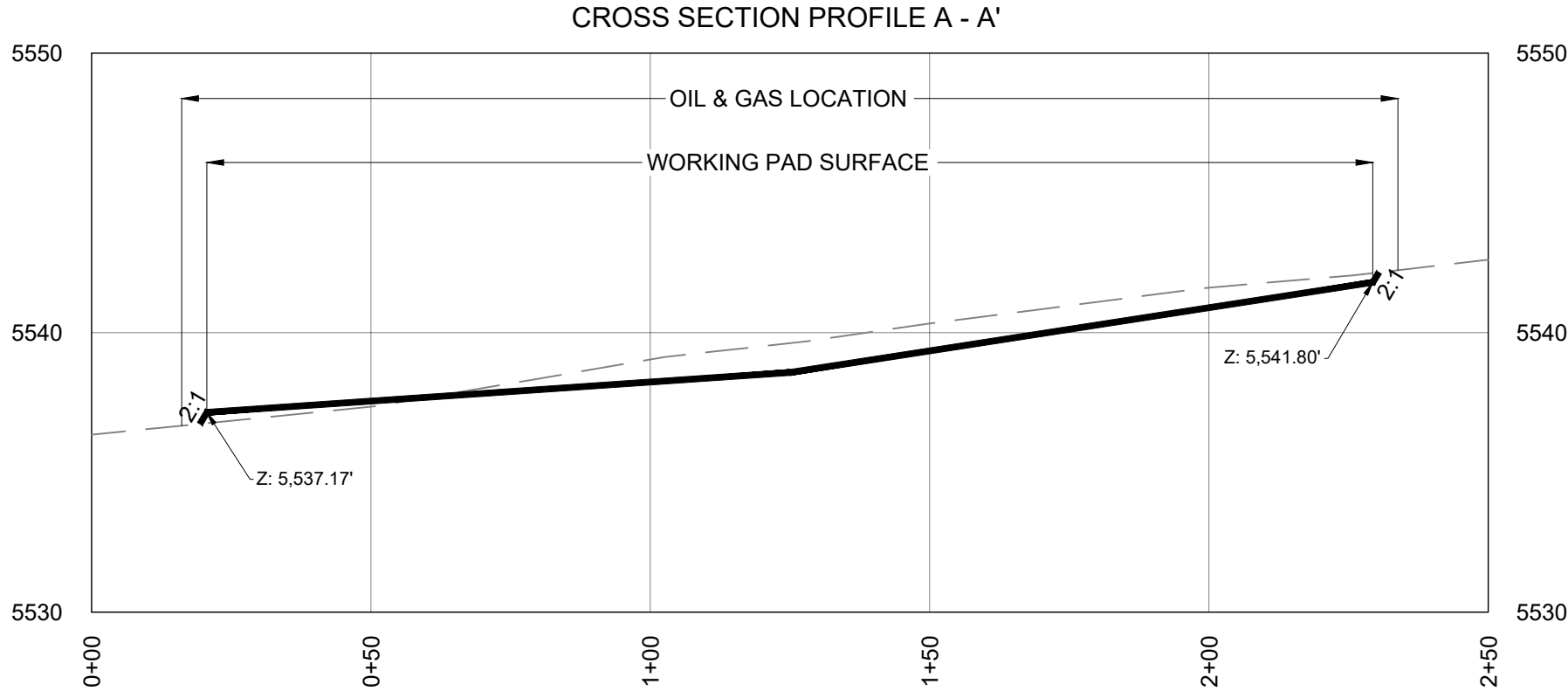
CONSTRUCTION LAYOUT - PLAN VIEW

CONSTRUCTION LAYOUT - PLAN VIEW

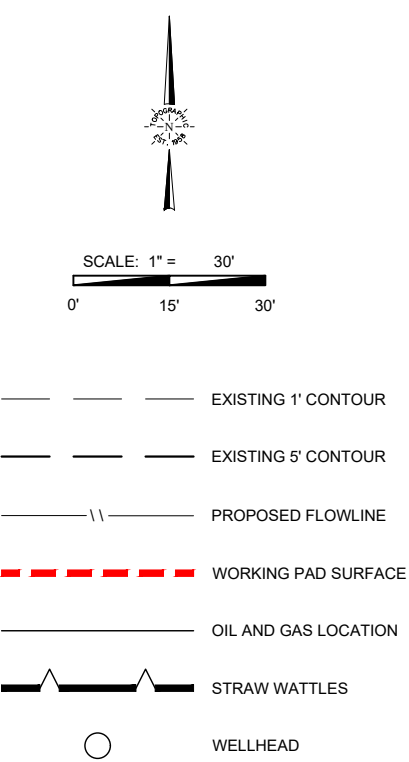
