Caerus plans to conduct additional investigative soil sampling activities to further delineate and characterize impacts along the southern and western exterior of the metal containment berm on the working surface of the pad. To better characterize these impacts up to five soil borings will be advanced within and surrounding the release footprint of the metal production tank containment. The soil will be characterized through visual and olfactory observations and field screening the soil using a photoionization detector (PID) to monitor for the presence or absence of volatile organic compounds (VOCs). See the ROWC associated with the previously submitted supplemental Form 27 (DN) 403089339 for additional details regarding the proposed investigation and characterization activities. Due to limited winter access and wildlife stipulations, no assessment activities were completed at the Site during Q4 2022. Activities are tentatively scheduled to commence in the spring/summer of 2023.
