I appreciate the table with associated HPH overlaps. I'm not seeing any 1202.c. Greater Sage-Grouse Lek Site buffer overlaps, so CPW does not have any major concerns with these activities. Furthermore, given the winter that we're having, I'm assuming reseeding work likely won't be able to occur until late spring/early summer? If that is the case, the lekking season for grouse should be wrapped up and disturbance associated with these reseeding efforts will be minimal. Let me know if you have any questions or I can help with any other information.
