Operator Comment: On 11/10/2022 a second muffler was installed on the active compressor to mitigate sound. A subsequent noise survey indicated day time readings were below the required thresholds. In parallel, a well engineering evaluation indicated an electric pump jack was a possibility which would eliminate the need for the compressor and efforts were started for its installation; this pump jack installation is currently waiting on the Form 4 #403273598 approval. The compressor was shut down on 2/10/2023 awaiting the electric pump jack installation, eliminating the site's primary noise source. Since the installation timing is soon, a noise survey per Rule 423 will be completed after the electric pump jack is installed to confirm the site's compliance. An additional FIRR will be submitted with the noise survey (estimated for April 2023).

COGCC Representative: Averages need to be below nighttime ads well and below 60 db(c) at residence all times

OPERATOR COMMENT AND SUBMITTAL

Comment: A future FIRR will be submitted with the noise survey with the compressor shutdown and the electric pump jack installation. Noise at the location is significantly reduced.
