Comment

During this inspection, Staff observed undesirable vegetation (e.g. kochia and russian thistle) throughout the location that will need to be managed during the next growing season. A vegetation assessment could not be performed at this time and the location will be re-inspected at a future date to document compliance with Rule 1003 and will therefore be placed In-Process until that time. Operator shall continue to monitor and manage this site until the location meets Rule 1003 standards, including stormwater and weed management. Operator shall submit a Form 4 Interim Reclamation Complete notice when the location meets Rule 1003 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1003.
