On 2/13/2023, Reclamation Specialist O'Malley conducted a field inspection at Caerus Piceance LLC's BASS-67S93W/14SWNE Location #334610 in Garfield County, Colorado.

This is a follow up to inspection #702801039 to assess compliance with a good housekeeping/trash corrective action. Corrective actions from inspection #702801039 have been addressed.

The following compliance issues were observed during this inspection:

- Staining at produced water/condensate tank drain
- Bull plug not installed on tank drain line
- Wildlife protection BMPs missing/insufficient on tank battery piping
