2. Set 50 sack cement plug at 3550-3700.
3. Set 50 sack cement plug at 150-300.
4. Mix 5 sack cement plug by hand at top of 8 5/8".
5. Cut off casing 3 feet below ground level and weld plate on 8 5/8" casing.
