On 3/2/2023 at approximately 12:45, Compliance Inspector Matthew Morris conducted an on-site inspection at LARAMIE ENERGY LLC, Shell/797-09A at Location ID #335018 in Garfield County, Colorado.

Normal production operations were observed.

During the inspection, the following compliance issues were observed:

- 1) Casing flange leak at wellhead
- 2) Open-ended load line at condensate tank
- 3) Storage of unused equipment on location (400 bbl condensate/produced water tank)

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, Wildlife Management area.
