INSTRUCTIONS

Within thirty (30) days after the plugging of any well, the owner or operator thereof shall file this form in duplicate for wells on Patented or Federal lands, and in triplicate for wells on State lands, give a detailed account of the manner in which the abandonment or plugging work was carried out, including the nature and quantities of materials used in plugging and the location and extent (by depths) of the plugs of different materials; records of the amount, size and location (by depths) of casings and junk left in the well; and a detailed statement of the volume and weight of mud fluid used.

DETAILS OF WORK

1. Set 4 1/2" O. D. 9.5# J-55 casing at 5065.84' and cemented with 85 sacks Pozmix A 50-50.
2. Perforated with 6-1/2" bullets/ft 4962 to 4971. 54 bullets total.
3. Treated with 25 gals Apted 300 and 40 gals. Fre-flo.
4. Treated with 10,000 lbs sand in 10,000 gals. refined oil.
5. Acidized with 500 gals. 7 1/2% MCA.
6. Treated with 10,000 lbs. sand in 10,000 gals. refined oil.
7. Placed 5 sack cement plug 4935' to 4985'.
8. Shot 4 1/2" O. D. 9.5 lb; J-55 casing at 4231'.
9. Pulled 4231' of 4 1/2" O. D. casing from well. Left 4 1/2" O. D. casing in well from 4231' to 5065.84'.
10. Placed 10 sk cement plug from 78' to 105'. Left 7" O. D. 20 lb. J-55 surface casing in well. Surface casing from 2' below ground level to 98.33'. Surface cemented with 55 sacks Pozmix A 50-50.
11. Placed 5 sk cement plug from 2' below ground level to 18'.
12. Well Plugged and Abandoned 10:30 P.M. - 6-16-58.
