Comment: Stormwater and erosion control BMPs missing or insufficient on the Location; tracking controls not observed; tracking evident; grading alone insufficient.

BMPs to allow for proper stormwater discharge from the Location are missing or insufficient, resulting in ponding and destabilization of the working pad area.

It was also observed that Operator appears to have pushed soils beyond the perimeter of the working pad; soils were observed covering vegetation; soils are unconsolidated and a pollutant source; BMPs to minimize sediment transport from the soils missing or insufficient.
