COGCC Inspection Report Summary

On Wednesday 3/15/2023, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP Miller 11, at Location # 334708 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

C/A (stored equipment) has not been addressed from previous inspection document # 700703641. All other C/A's appear to have been addressed.

During this inspection the following compliance issues were observed:

1. Meter calibration card not conspicuously posted.
 2. Stored/unused equipment from previous inspection is still present. C/A date remains the same (3/8/2022)
- Refer to photograph of observed compliance issue.

A follow up on this site inspection may be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
