Basis for Review: Equipment is not owned or controlled by the operator

Operator Comment: This is actually outside of the interim reclaimed area of this pad. Silt fence was installed by construction crews for the housing developers when they began construction well over a year ago. This damaged segment has remained in place since. We don't believe POCO is responsible for removing or replacing erosion control related to the development of these roads and homes as these best management practices were not necessary prior to the homes being built around the facility. As you can see in the photos below, contractors are still performing dirt work and landscaping on the homes near the silt fence mentioned.

COGCC Decision: **Not Approved**

COGCC Representative: This Factual review request is not approved. Operator is responsible for stormwater controls on all interim reclaimed areas. From the photos provided by operator interim reclamation stormwater controls have not been implemented nor maintained. An additional inspection will be conducted soon to assess the interim reclamation area stabilization and proper functioning perimeter controls.

COGCC Supervisor: This Factual review request is not approved. Operator is responsible for stormwater controls on all interim reclaimed areas. From the photos provided by operator interim reclamation stormwater controls have not been implemented nor maintained.
