Comment

Operator has performed interim reclamation activities to reduce disturbance areas only needed for production operations. Undesirable vegetation (tumbleweeds) was observed within the interim reclamation areas. Interim reclamation areas are being managed with the observation of mowing operations. Perennial vegetation was observed throughout portions of the interim reclamation area. It should be noted that introduced grass species were planted that are not reflective of reference areas.

Operator shall continue to monitor and manage this site until the location meets Rule 1003 standards, including stormwater and weed management. Operator shall submit a Form 4 Interim Reclamation Complete notice when the location meets Rule 1003 standards.
