Laboratory analytical indicated a historical release occurred along the Front Range D #09-28 decommissioned flowline. Two soil samples exceeded COGCC standards for benzo(a)pyrene at 0.153 mg/kg, 1-methlanphthalene at 0.0171 mg/kg, 2-methylnaphthalene at 0.0285 mg/kg, benzo(a)anthracene at 0.227 & 0.0837mg/kg, naphthalene at 0.074 & 0.0276mg/kg, and TPH at 887 mg/kg.
